Northampton Community College is a leading two year institution located in Northeastern Pennsylvania. The college is an institution of choice for the unrepresented and the minority community in eastern PA. The current endowment for the college stands at \$85 million, putting it among the top ten community college endowments nationally.

Upon assuming the position I worked with senior leadership to successfully complete the construction of a \$6 million Center for Innovation & Entrepreneurship and lead the development of a long term strategic plan for the center. The center includes a 7,800 square foot state of the art maker space.

### Key Accomplishments

- Recruited and led key faculty and staff in developing a vision, mission and core values for the Center. Served on President's Executive Council.
- Established a 15 member External Advisory Board consisting of leaders from business, non-profits, education and the venture capital world.
- Partnered with Institutional Advancement in raising \$2.4 million to support 50 scholarships annually in entrepreneurship education and experiential learning opportunities.
- Designed and launched a 28 weeks 5 credits Start-Up Boot Camp experiential learning opportunity for students, the first of its kind among community colleges nationwide. The boot camp has 6 weeks of Design Thinking built into it and is sponsored by the National Association for Community College Entrepreneurship (NACCE).
- Partnered with Academic Affairs in designing and approving a three credit course in Entrepreneurial Mindset and Design Thinking that any Northampton student can take as an elective. This offering has also been expanded to dual enrollment students for area high schools.
- Partnered with Exploratory Studies in designing an 11 credit specialized diploma in Innovation & Design Thinking. The diploma will launch in fall 2024 and has a 2 credit internship built into it.
- Established a week long on-campus Entrepreneur in Residence program targeting business and non-profit leaders from Lehigh Valley, PA.
- Established a faculty and staff development program in Entrepreneurial Mindset and Design Thinking. To date 75 faculty and staff have successfully completed the program.
- Established a volunteer mentoring program for student and community start-ups. To date 20 Lehigh Valley community leaders are actively engaged in the program.
- Launched a virtual 14 weeks Small Business Management & Entrepreneurship certificate program focused on Product Development, Customer Discovery, Financing and Intellectual

- Property.
- Established a strategic partnership with the Service Core of Retired Executives (SCORE),
   Lehigh Valley. Through them 50 three hour workshops in small business, start-ups and non-profits are offered annually for a minimum fee.
- Brought 1 Million Cups, a Kauffman Foundation initiative to enhance the entrepreneurial ecosystem of Lehigh Valley. To date 200 plus local entrepreneurs have shared their story through the Lehigh Valley 1 Million Cups and nationally the Lehigh Valley chapter consistently ranks in the top 25 percent in weekly attendance.
